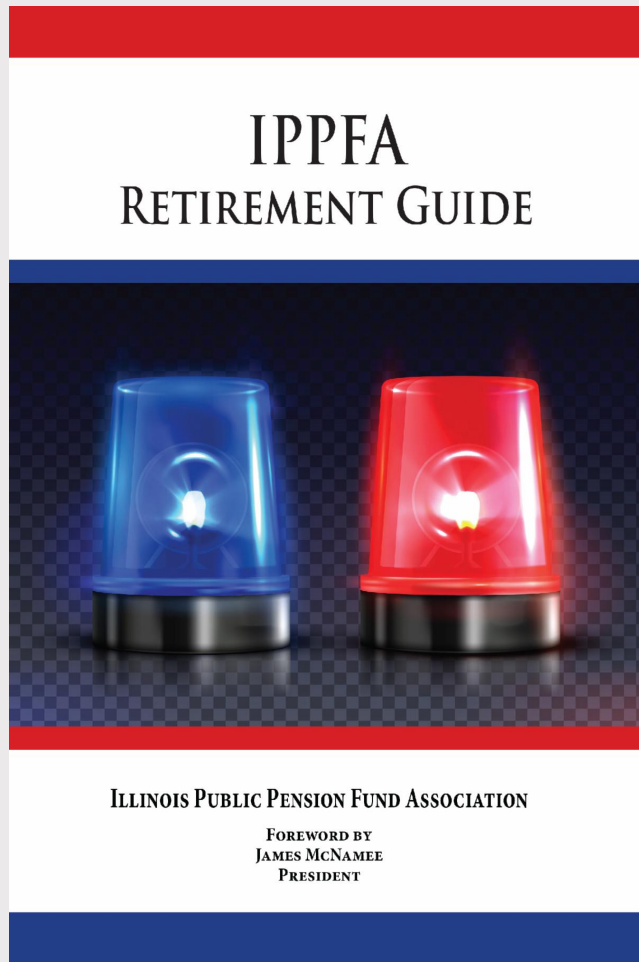
- Article 3 Police Pensions
